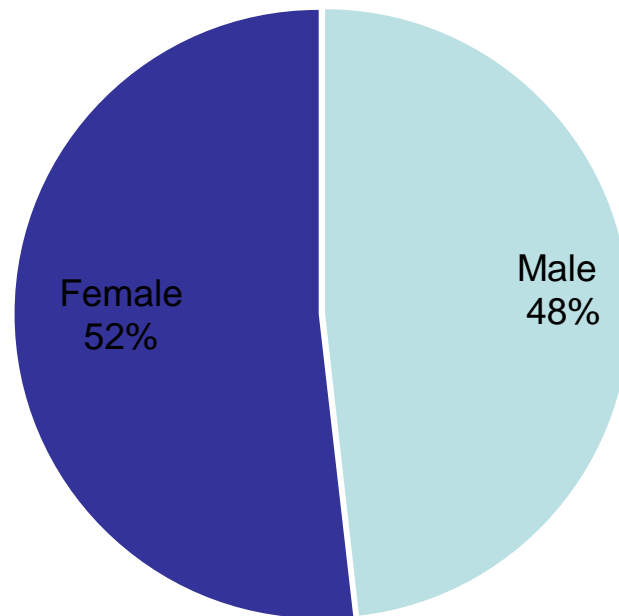

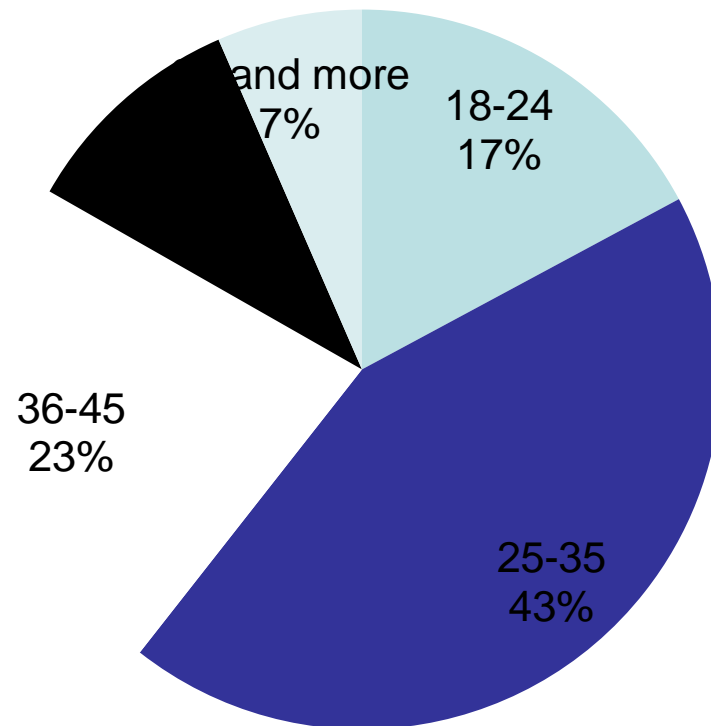

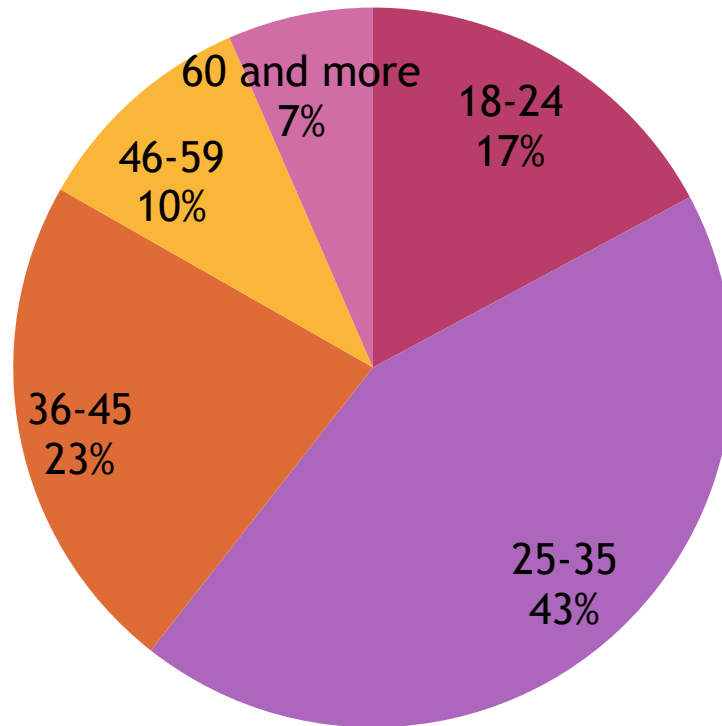
Respondents by age, 2010

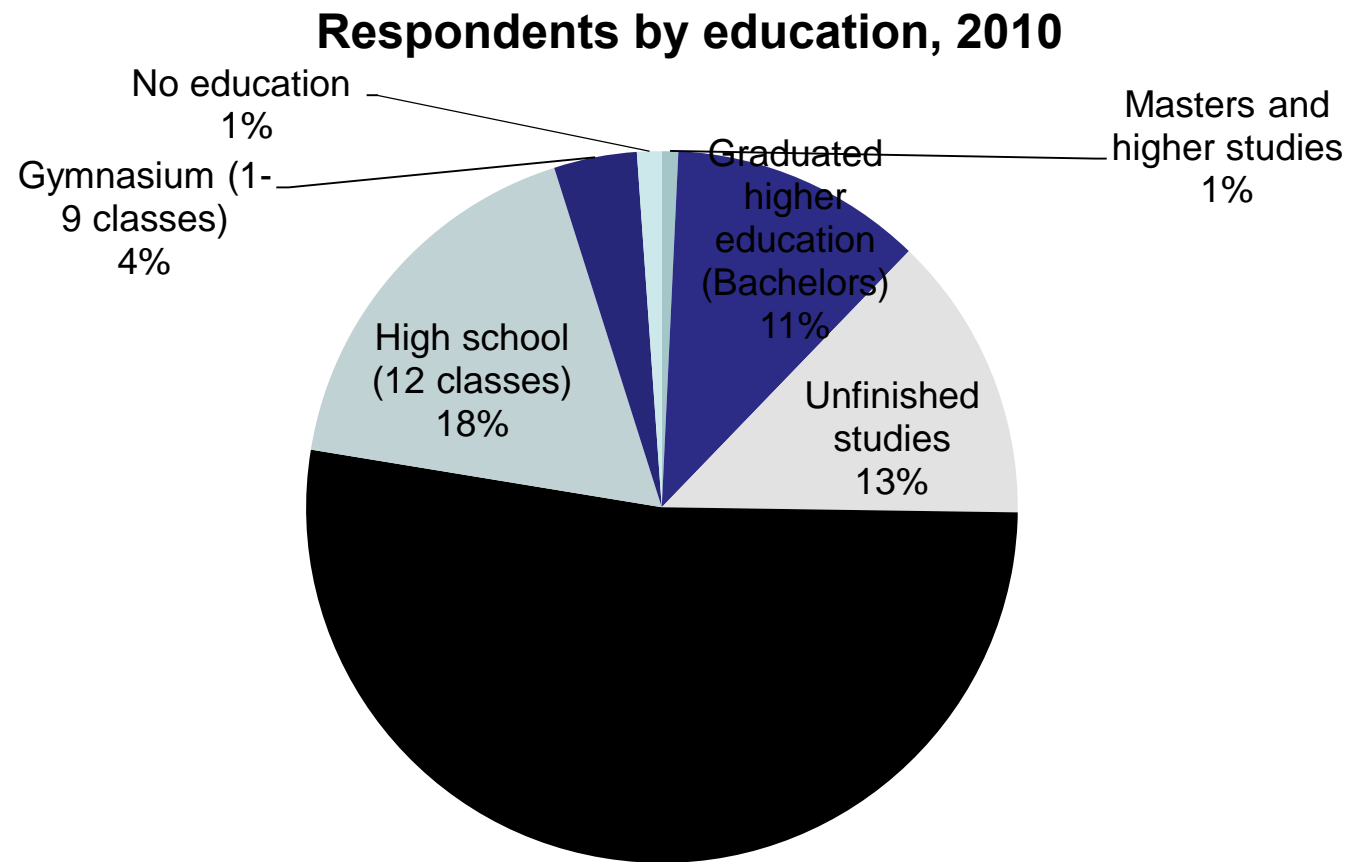

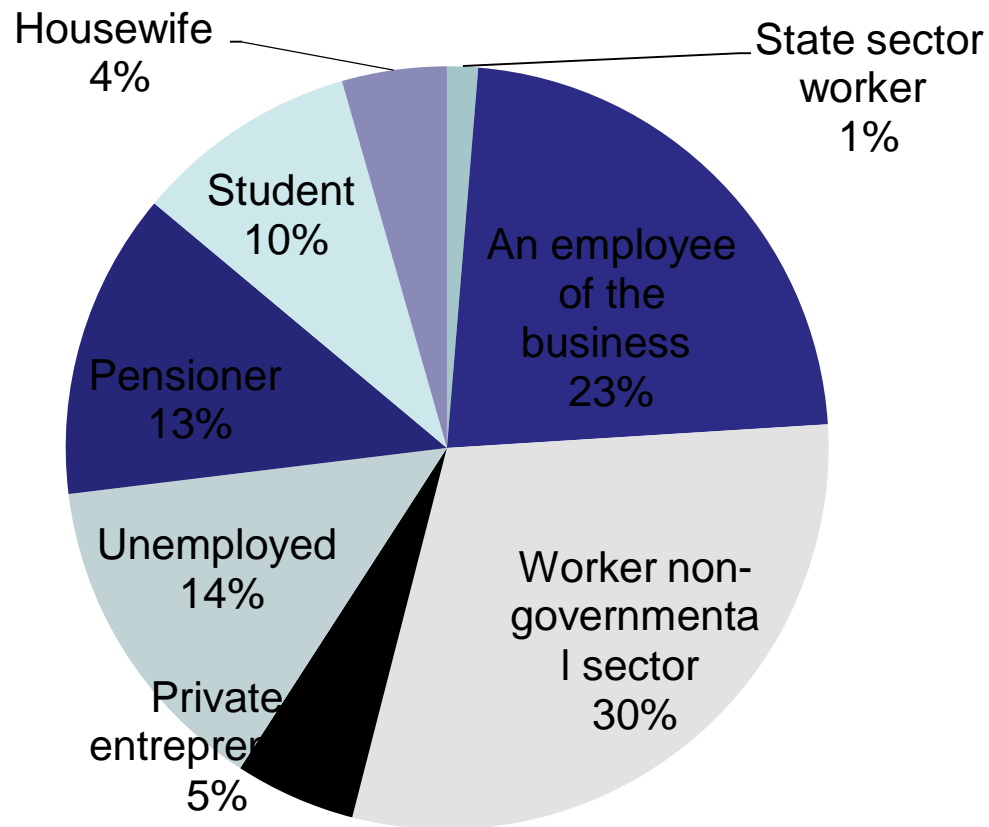

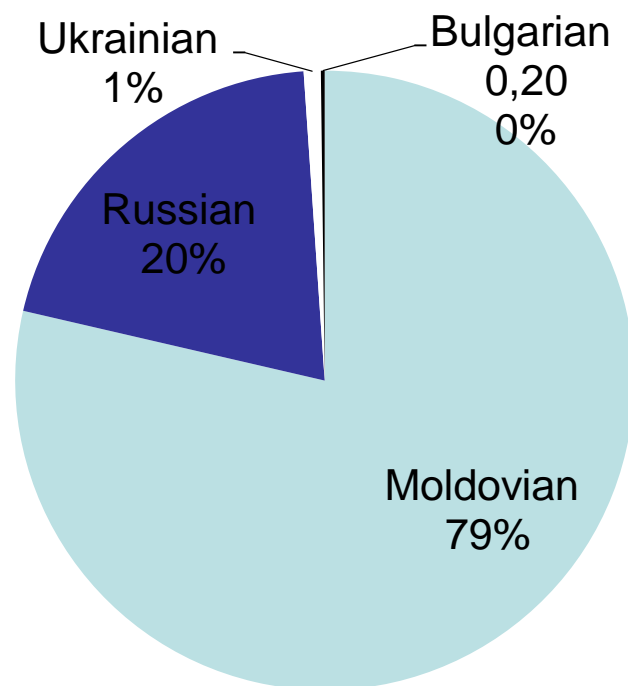
Respondents by occupation, 2010

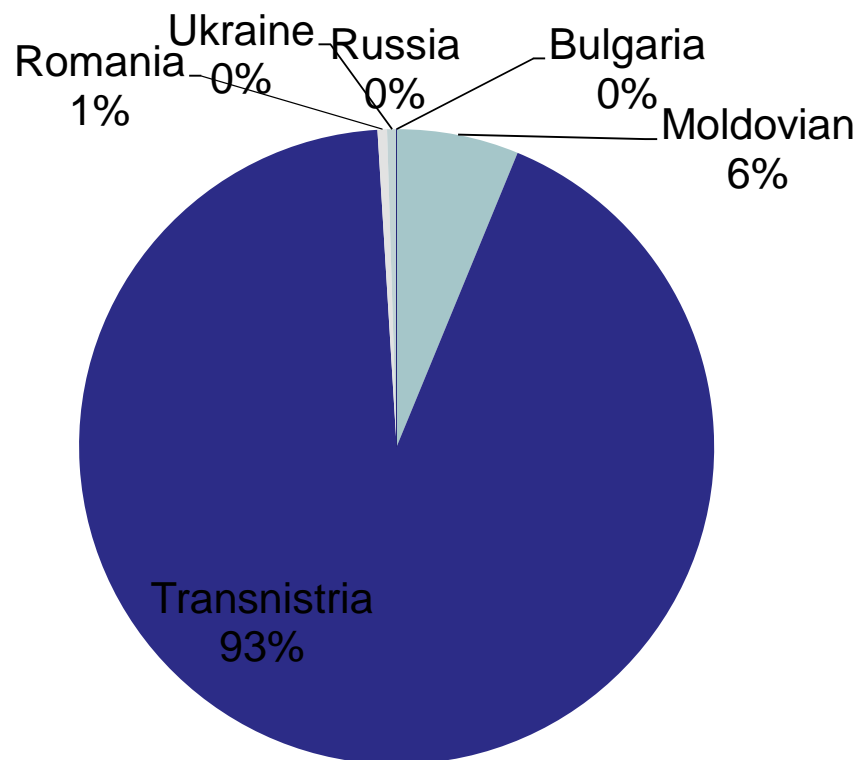

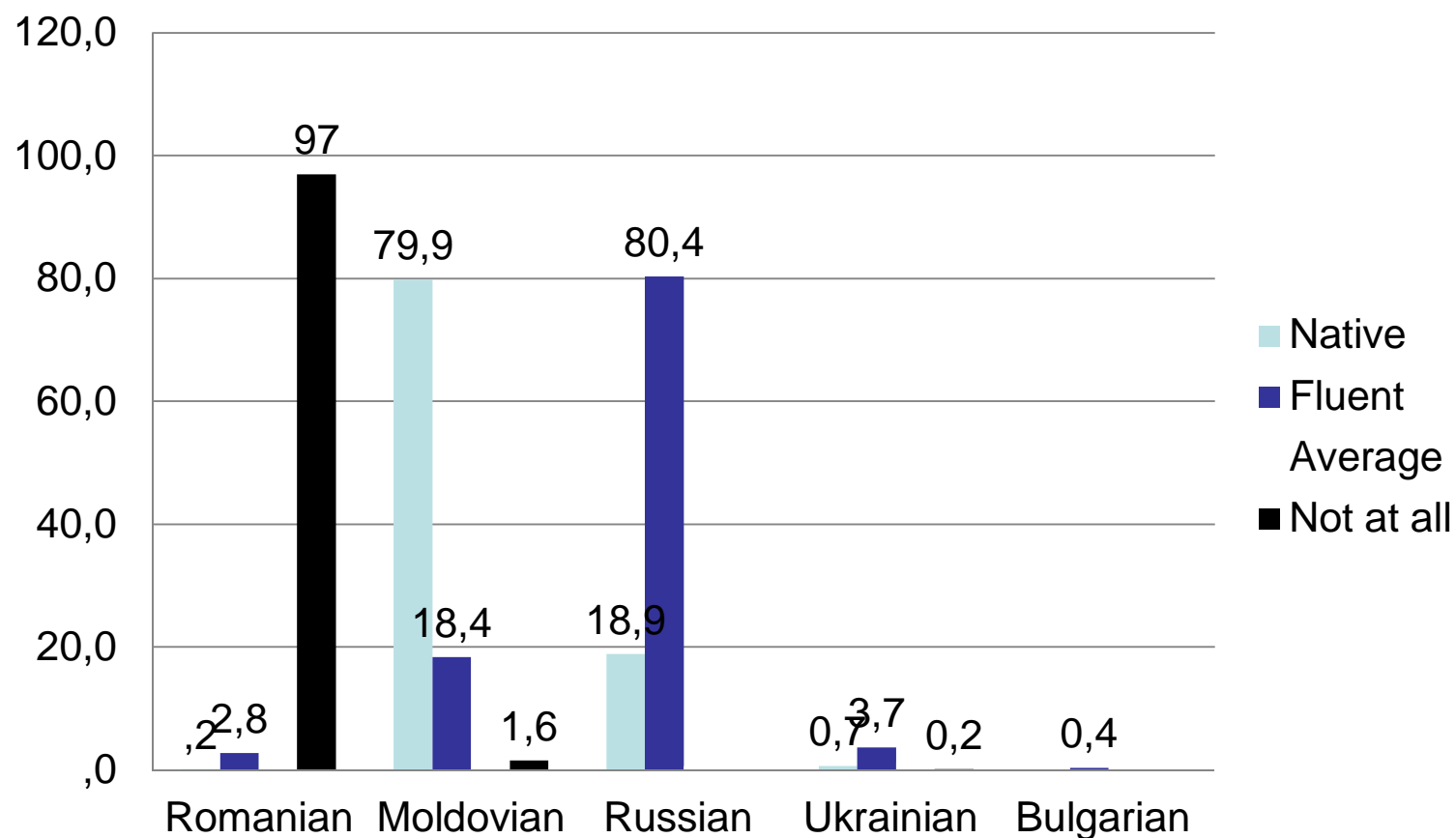

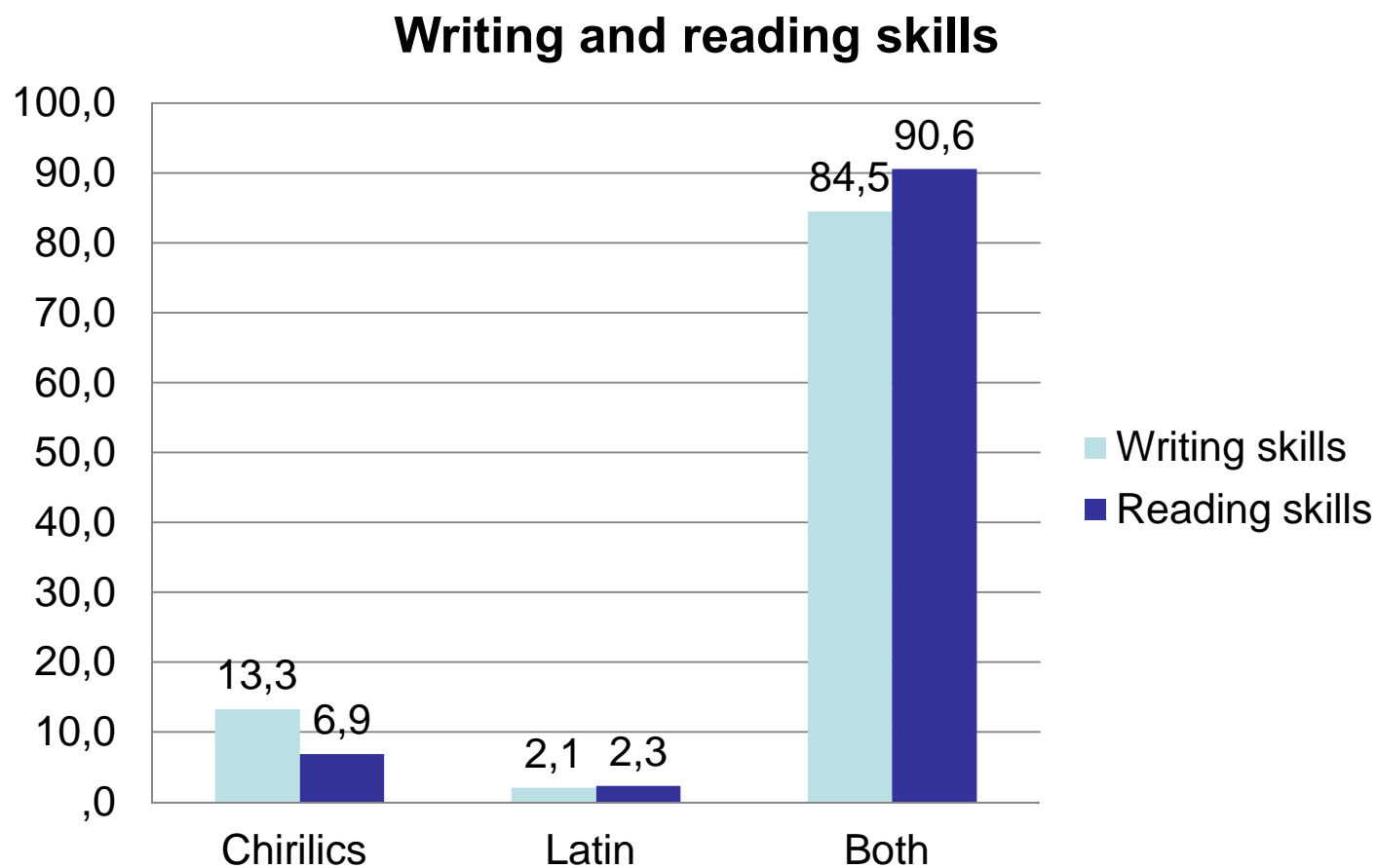

What languages do you speak? %



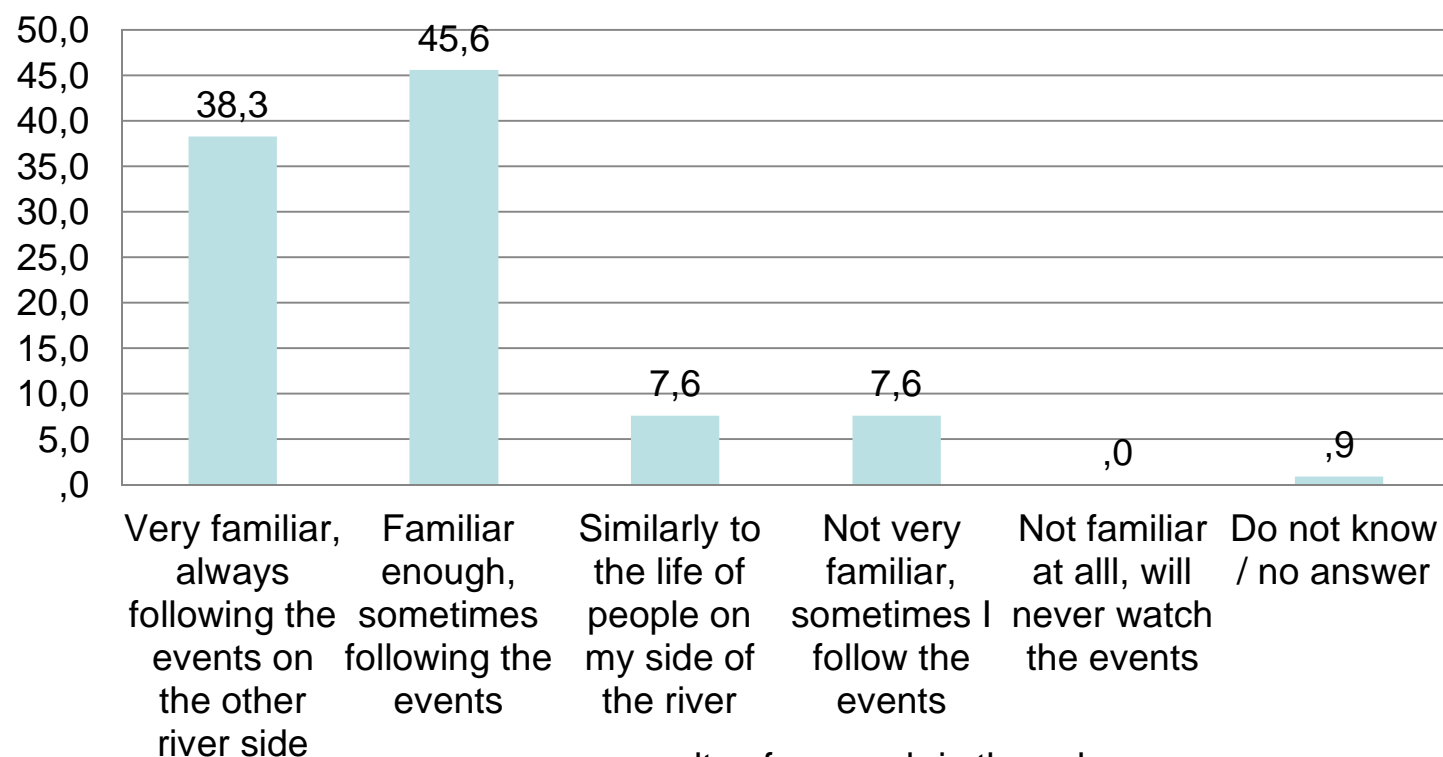

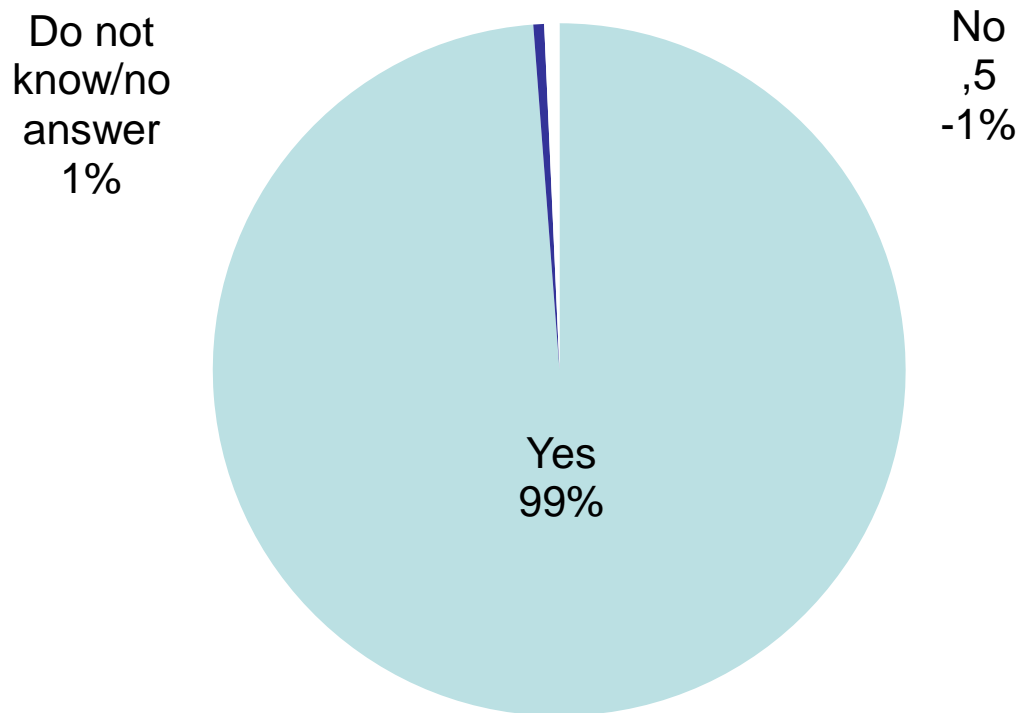
Are you familiar with social life (living standards, health care, education, cultural events) ofn the right bank of Nistru river, under the jurisdiction of Chisinau?

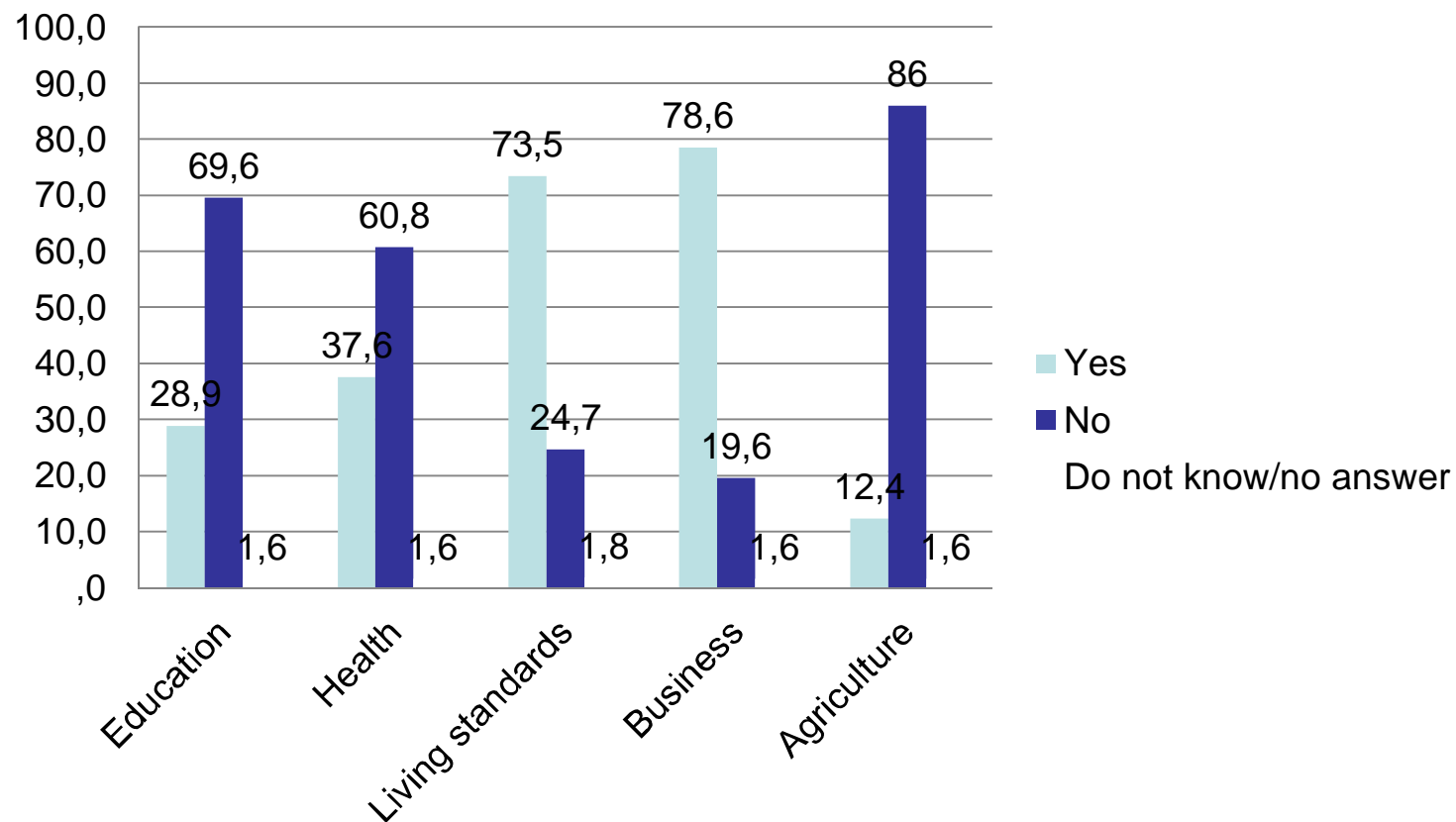

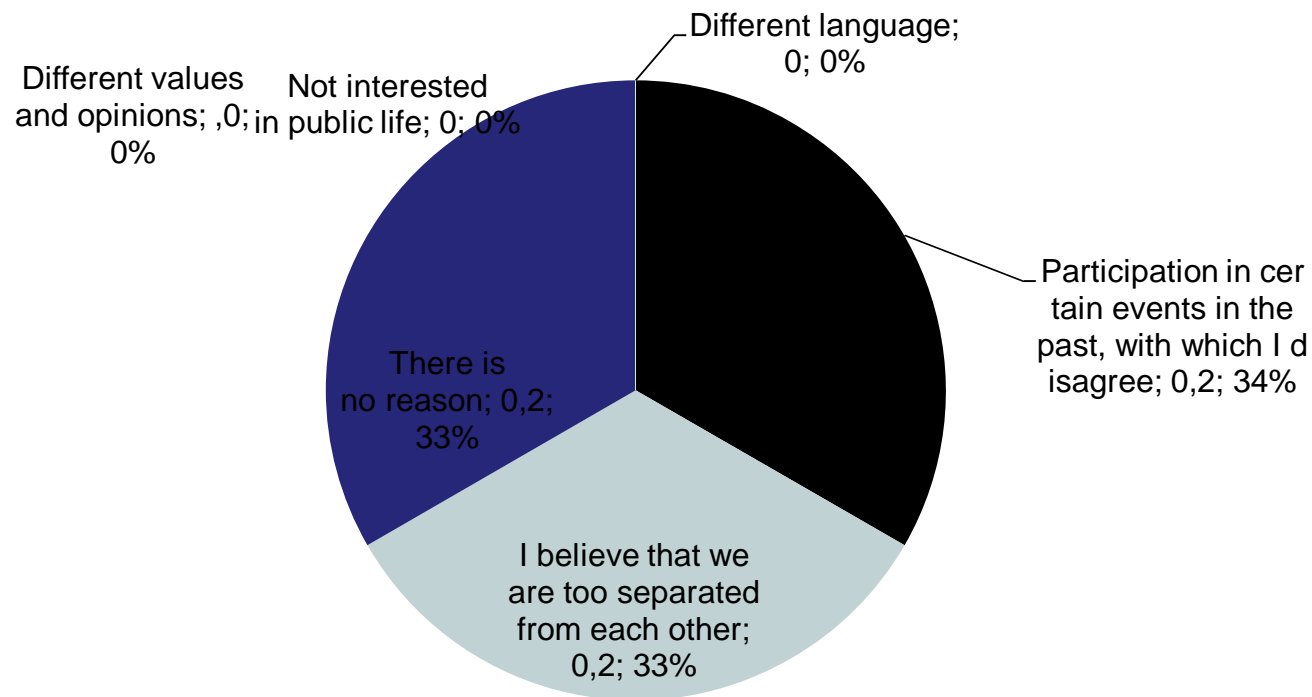

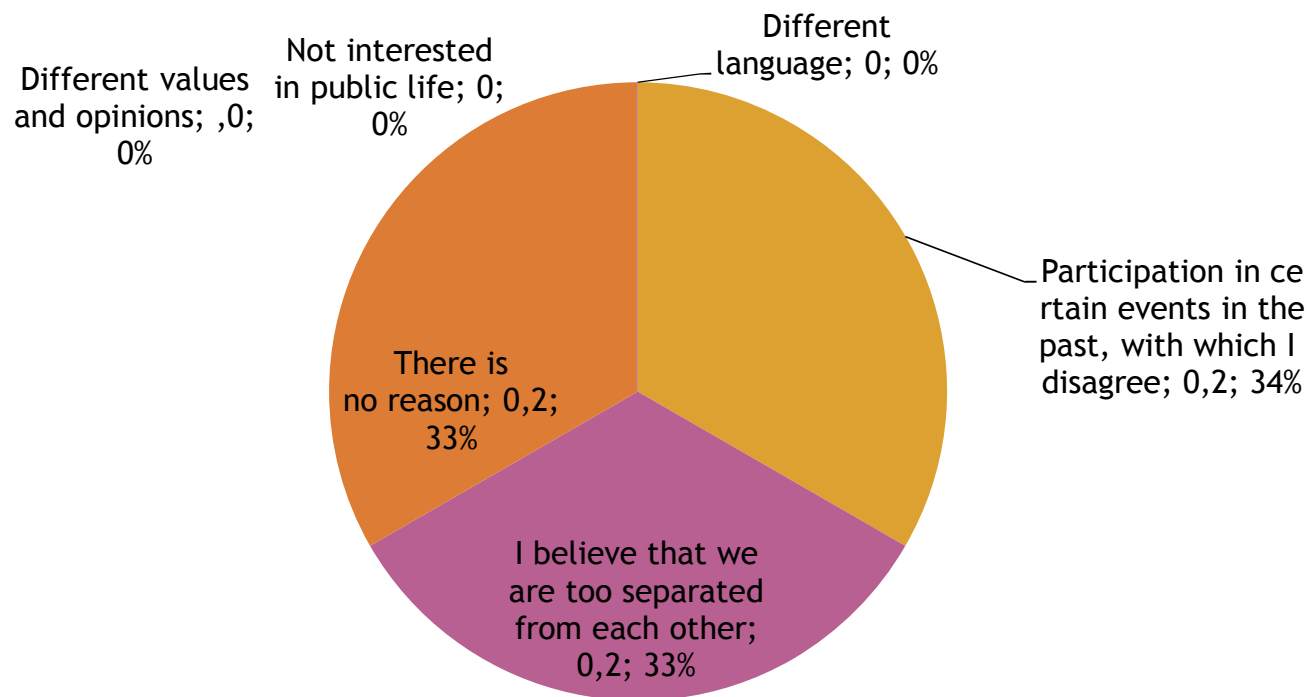
**Reasons for no interest of learning more about the population on the other side of Nistru river?

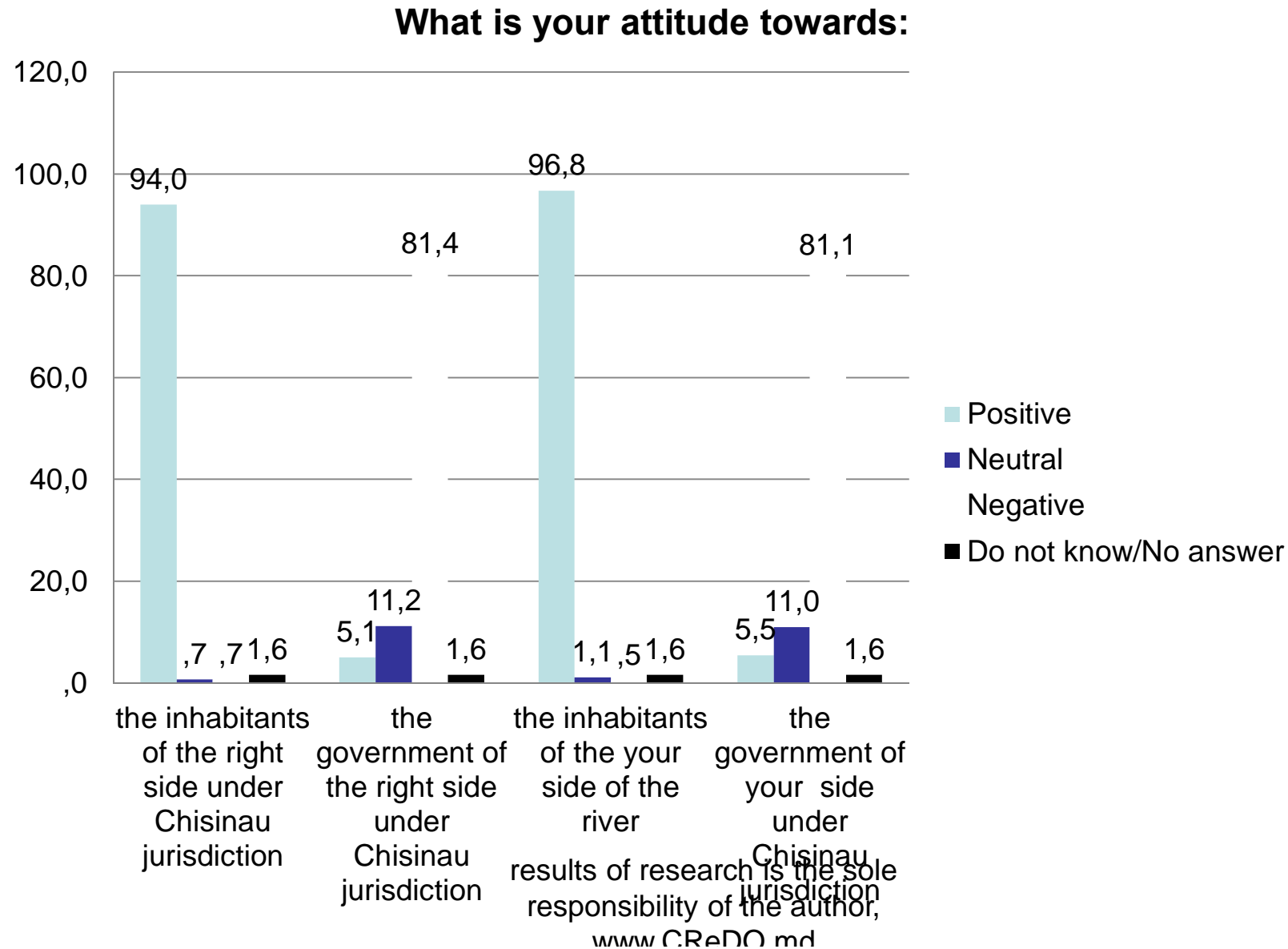

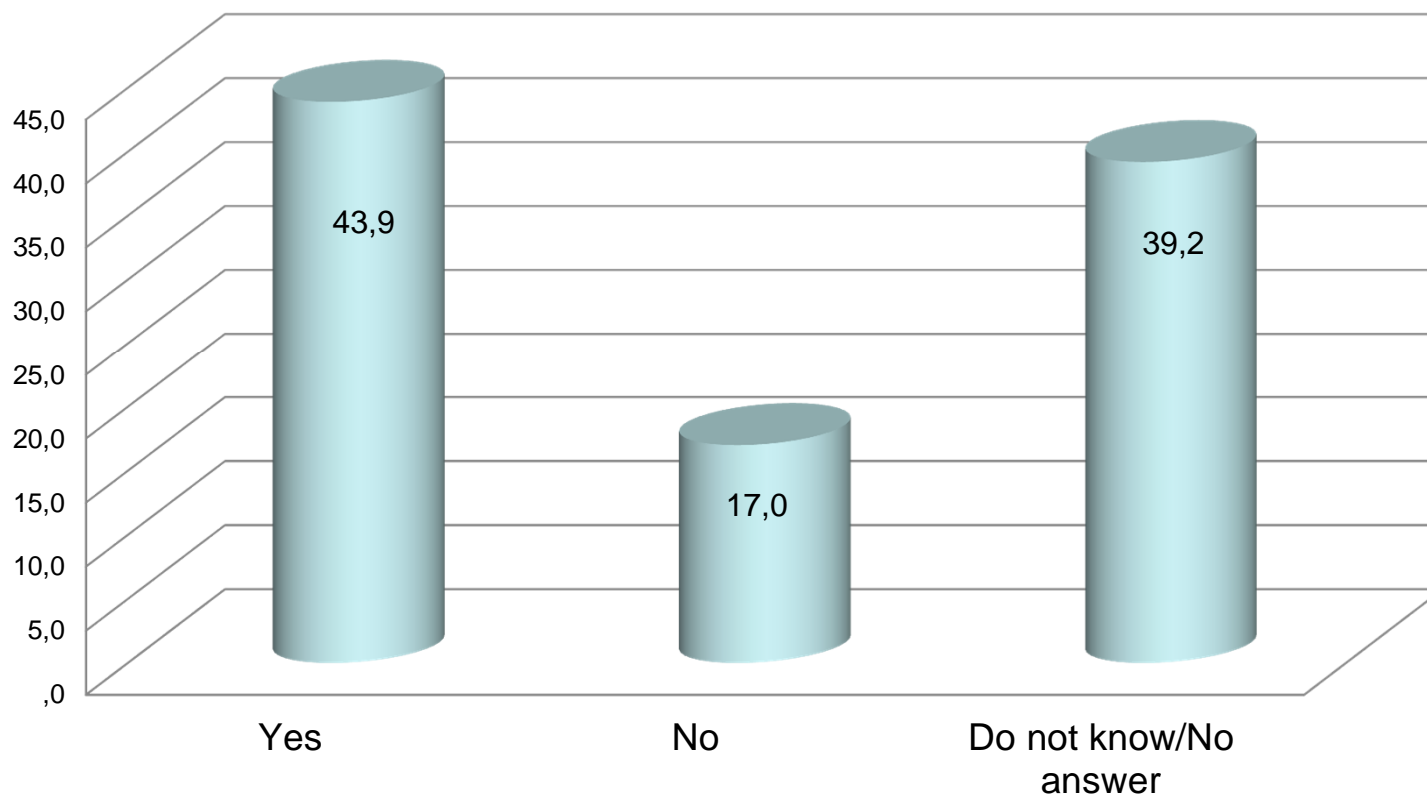

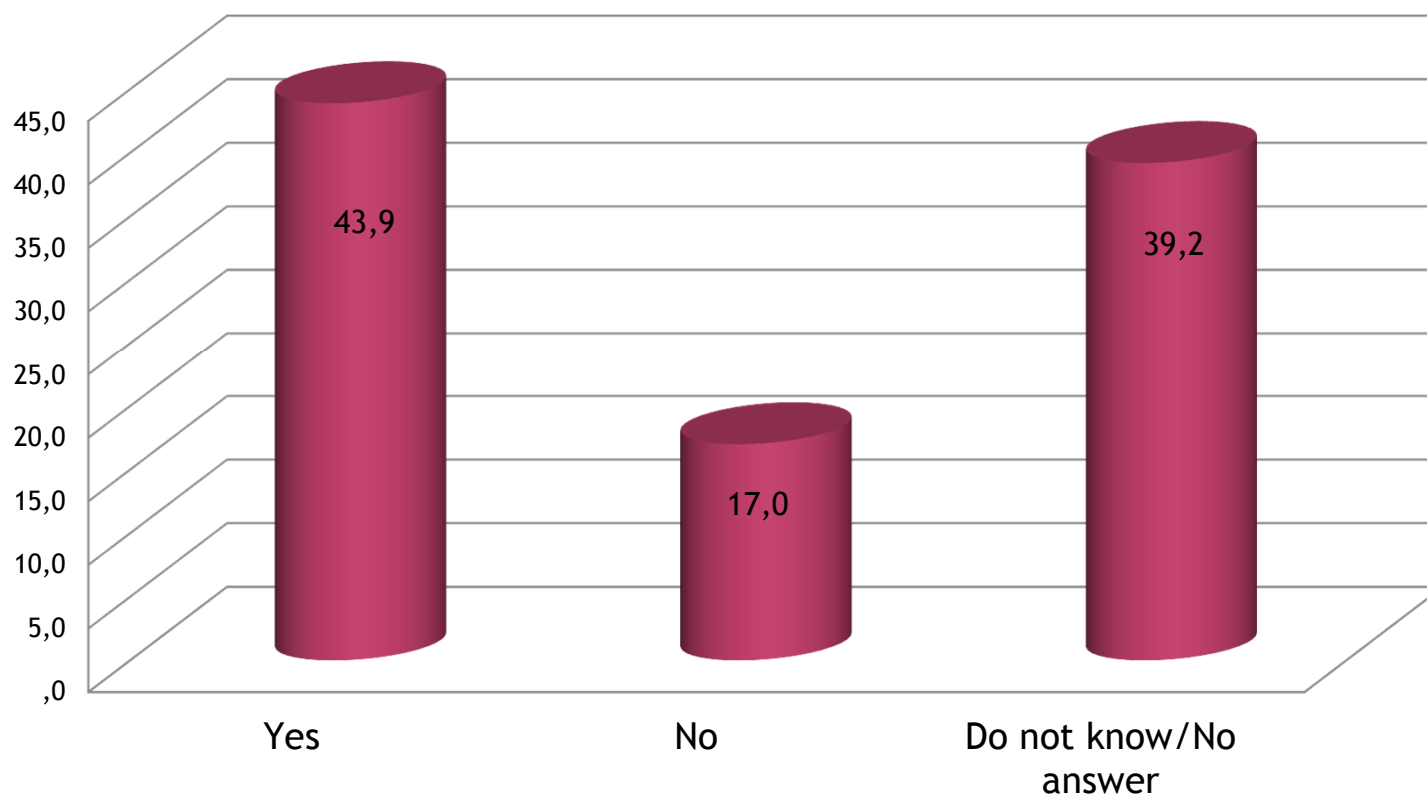

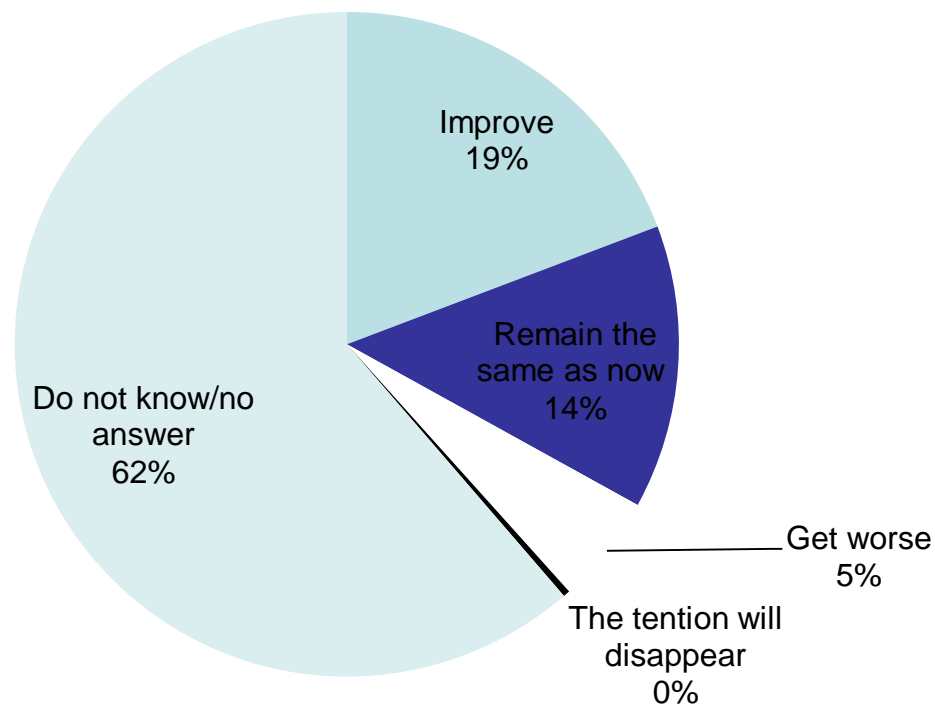

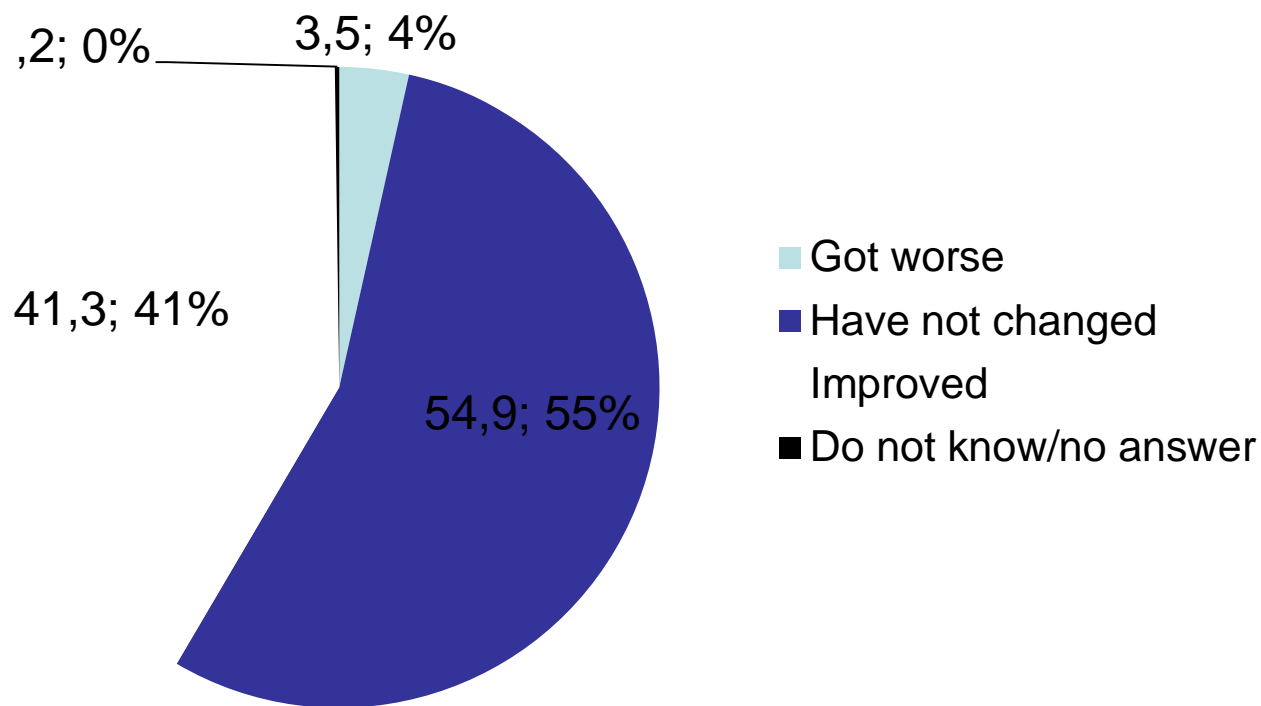

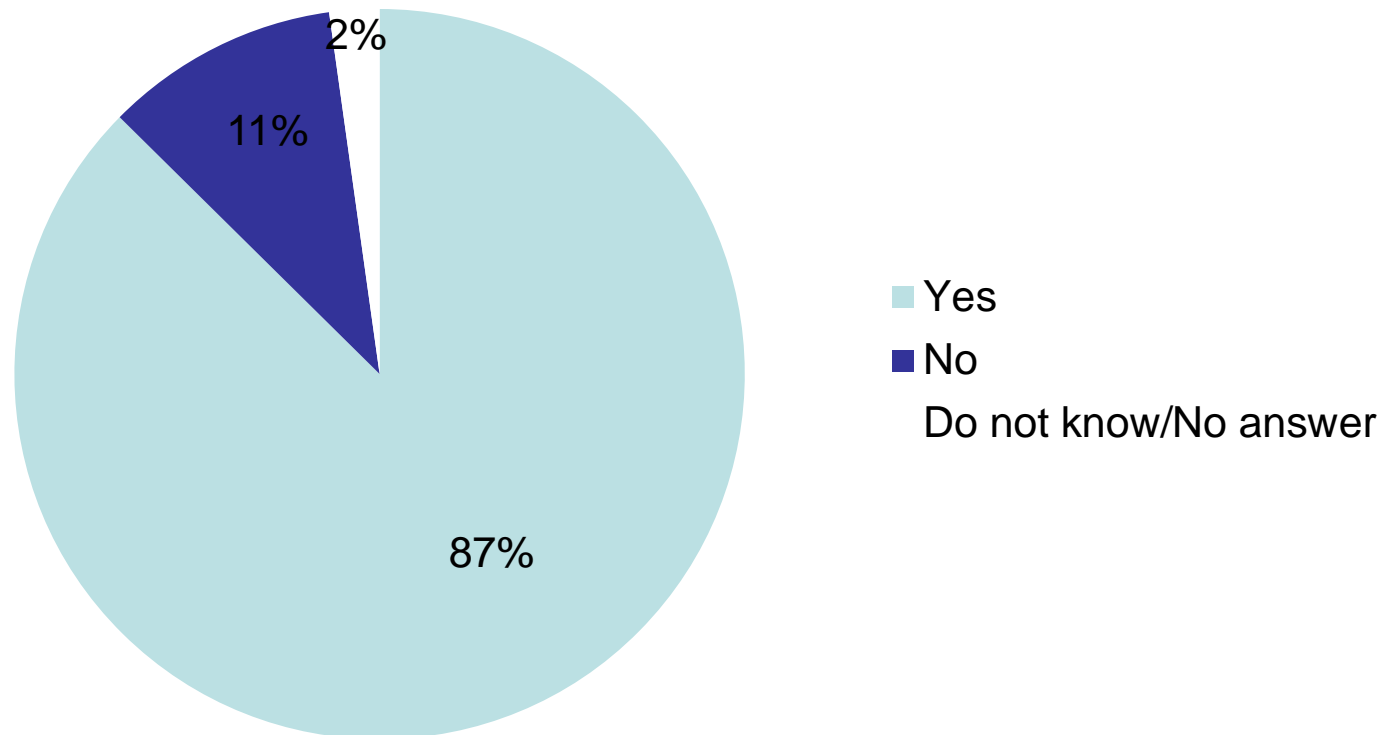

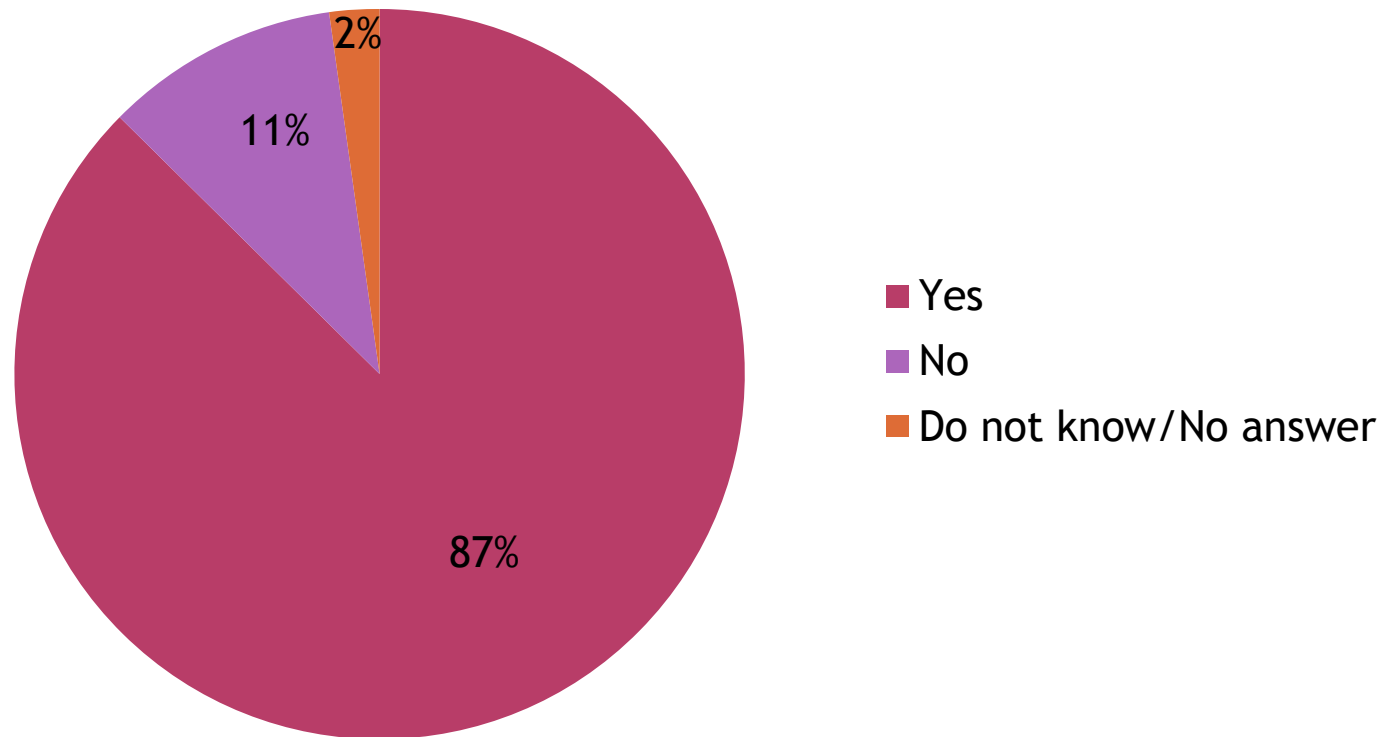

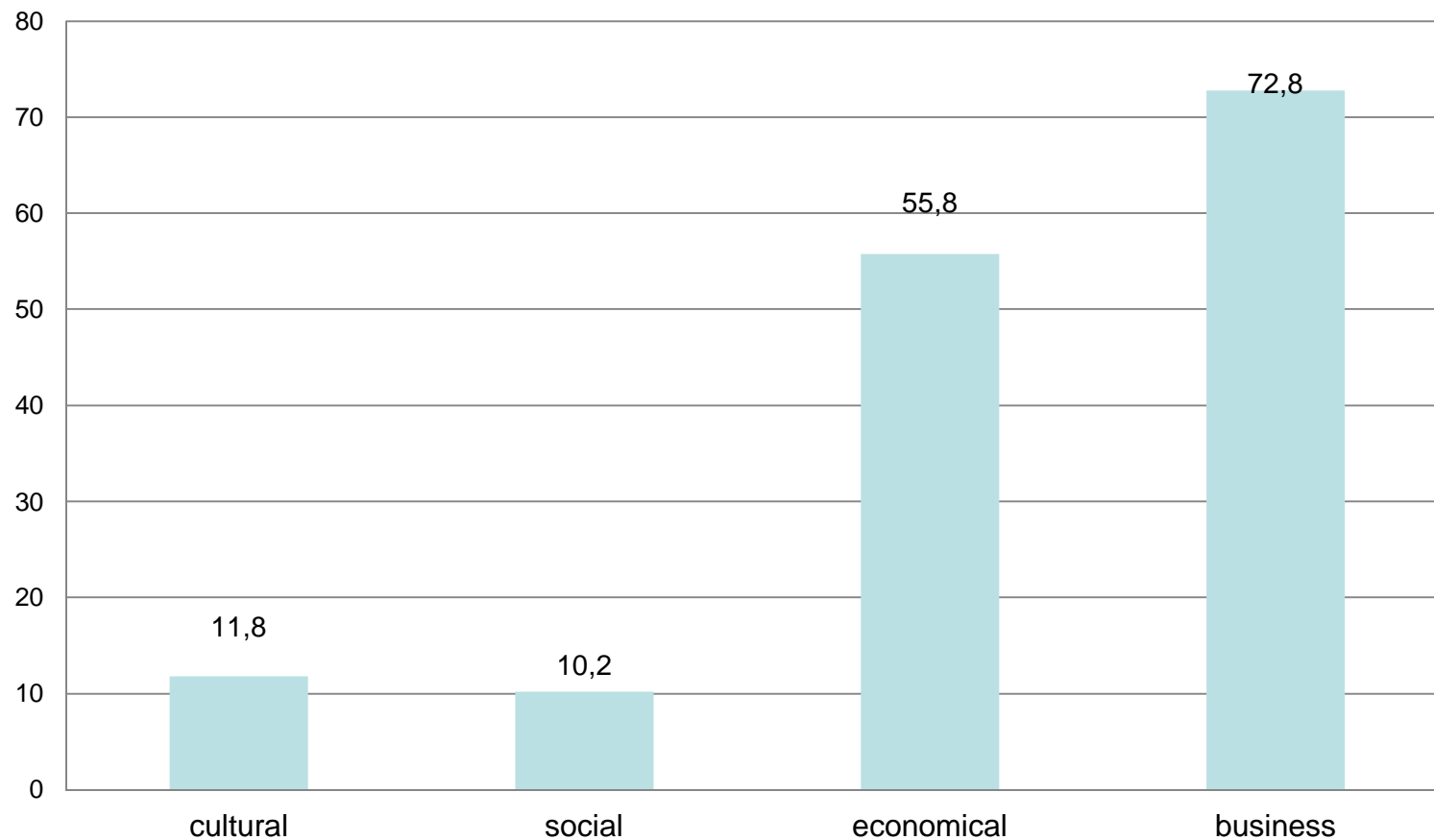

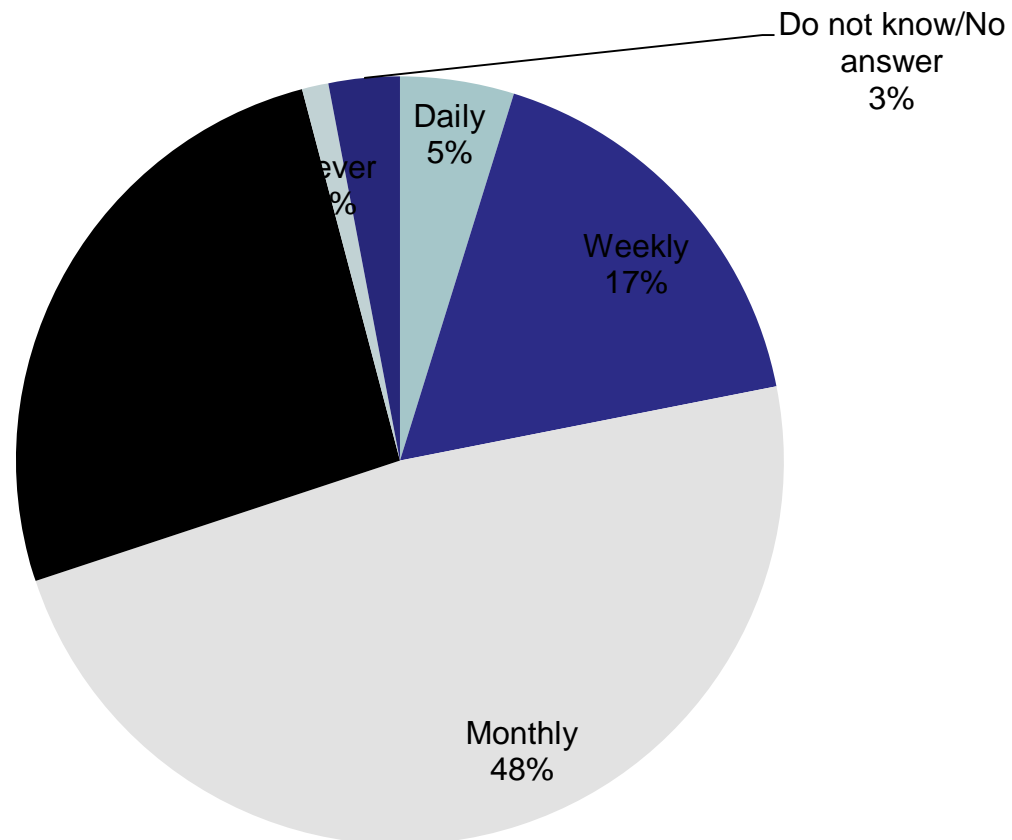

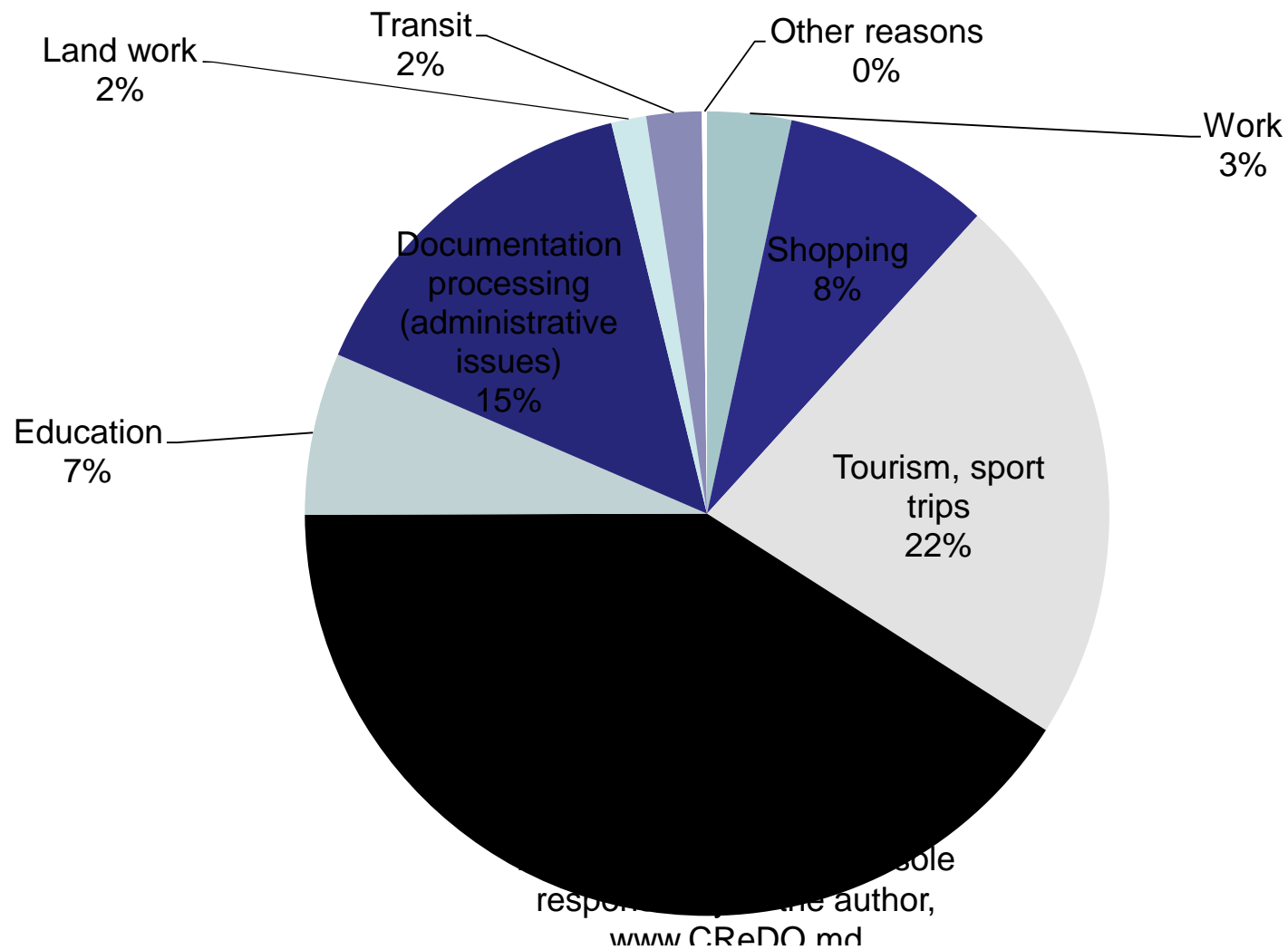
How often do you go on right bench of the river?

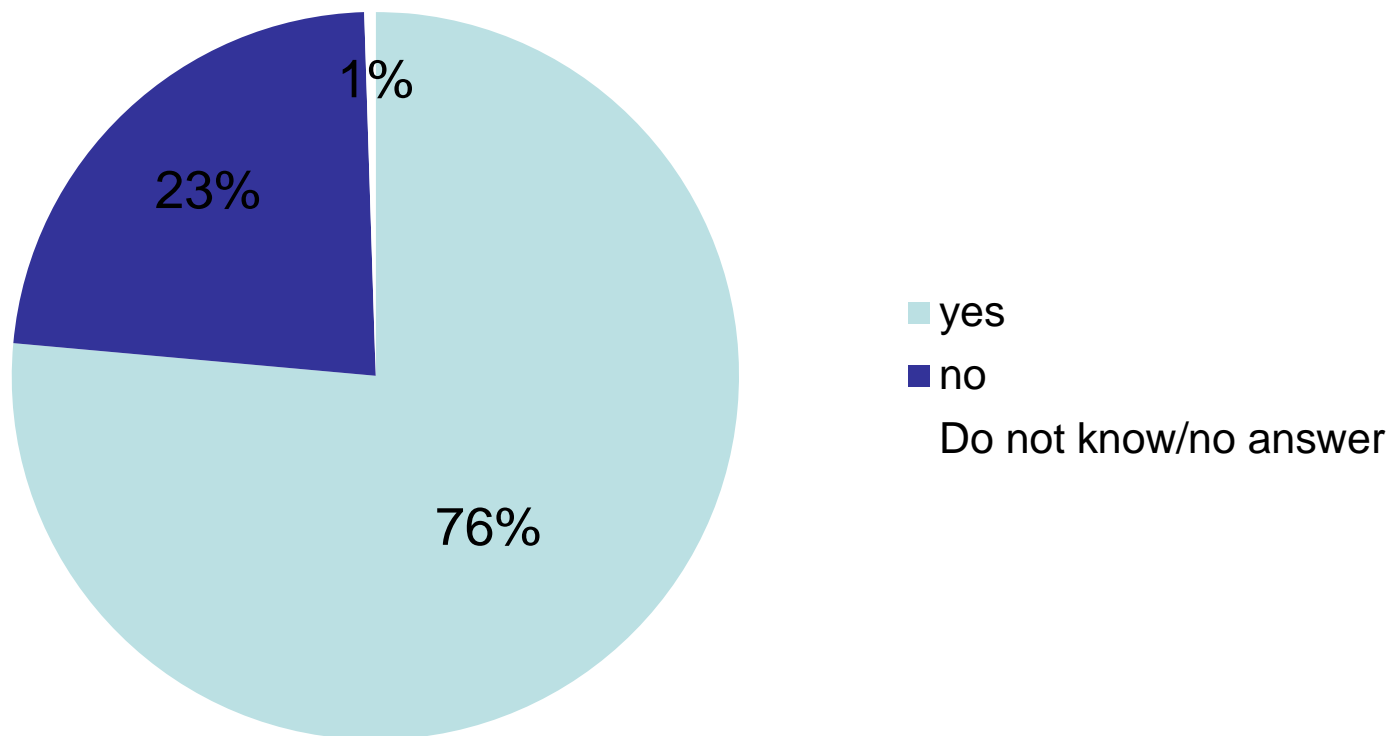

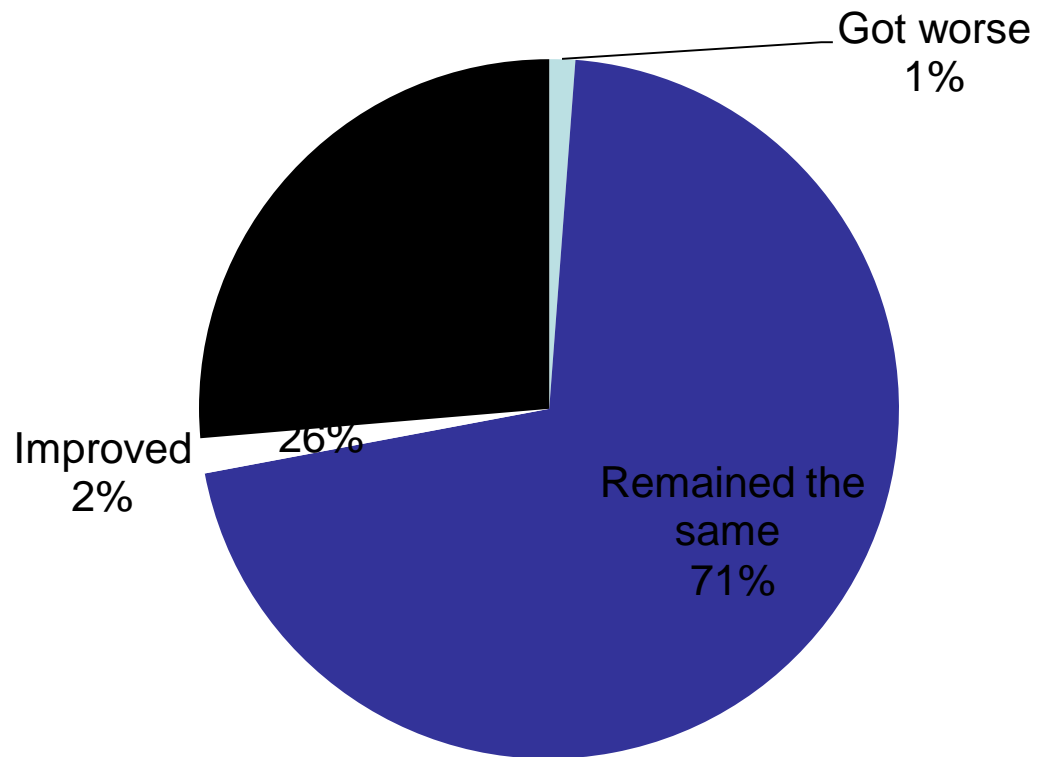

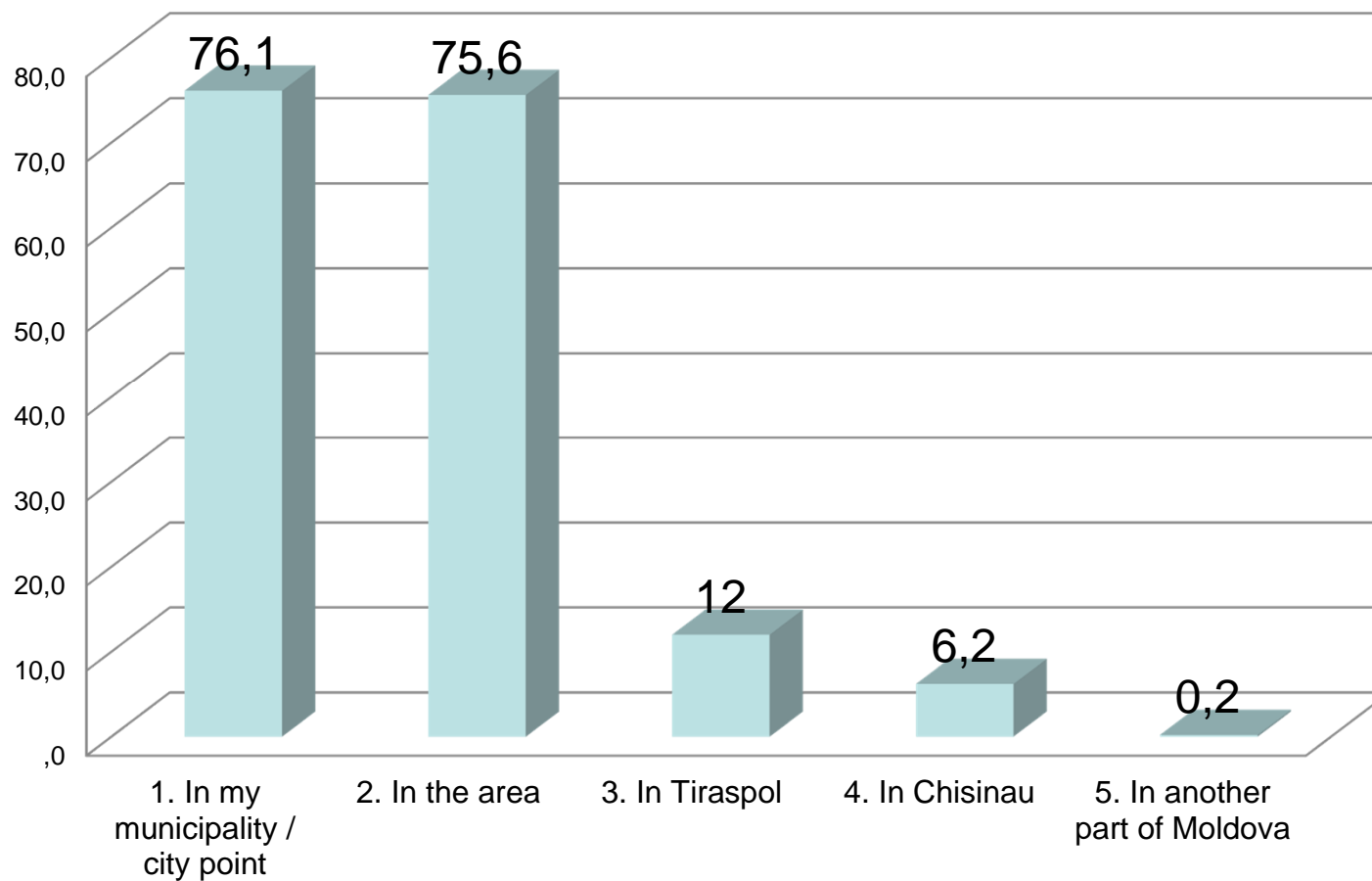

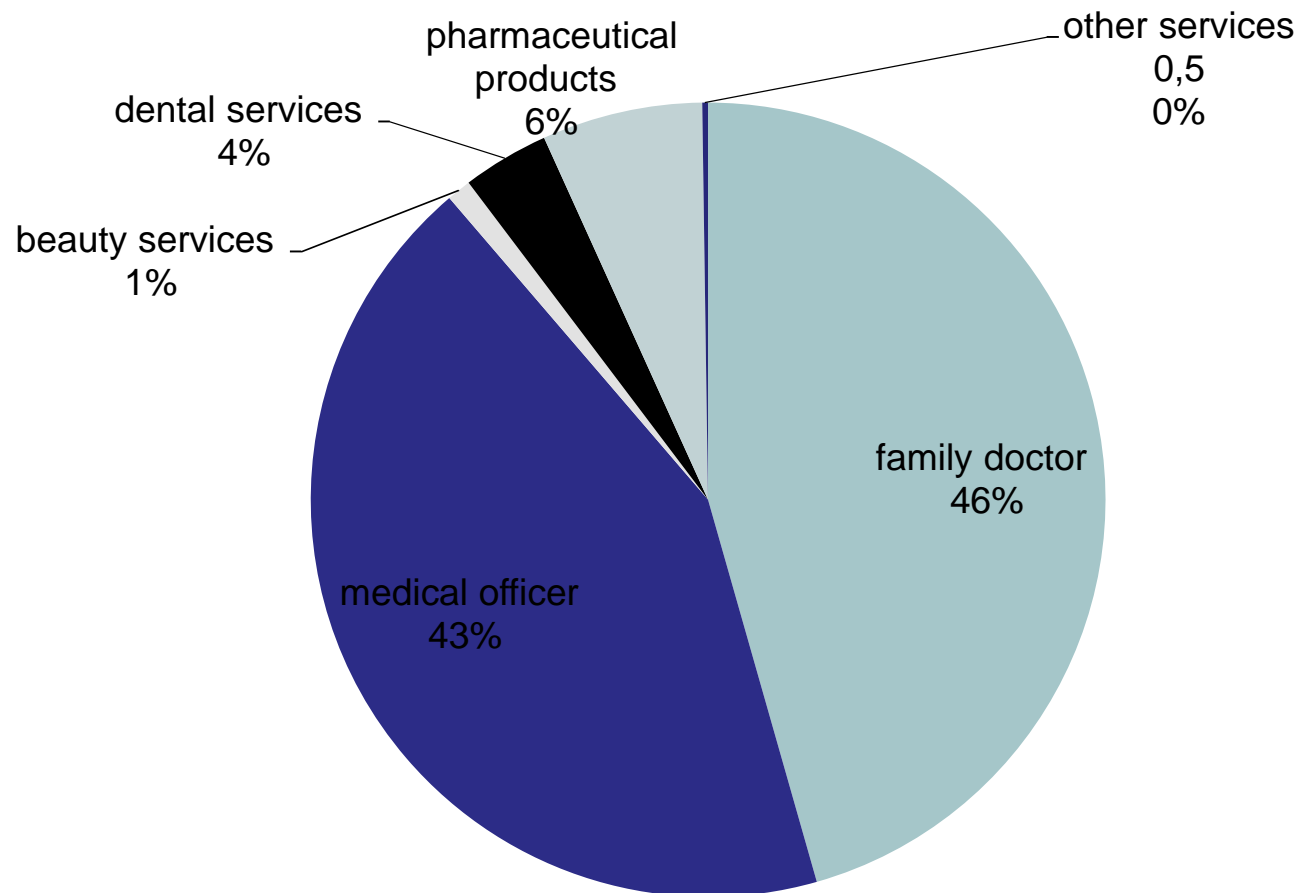

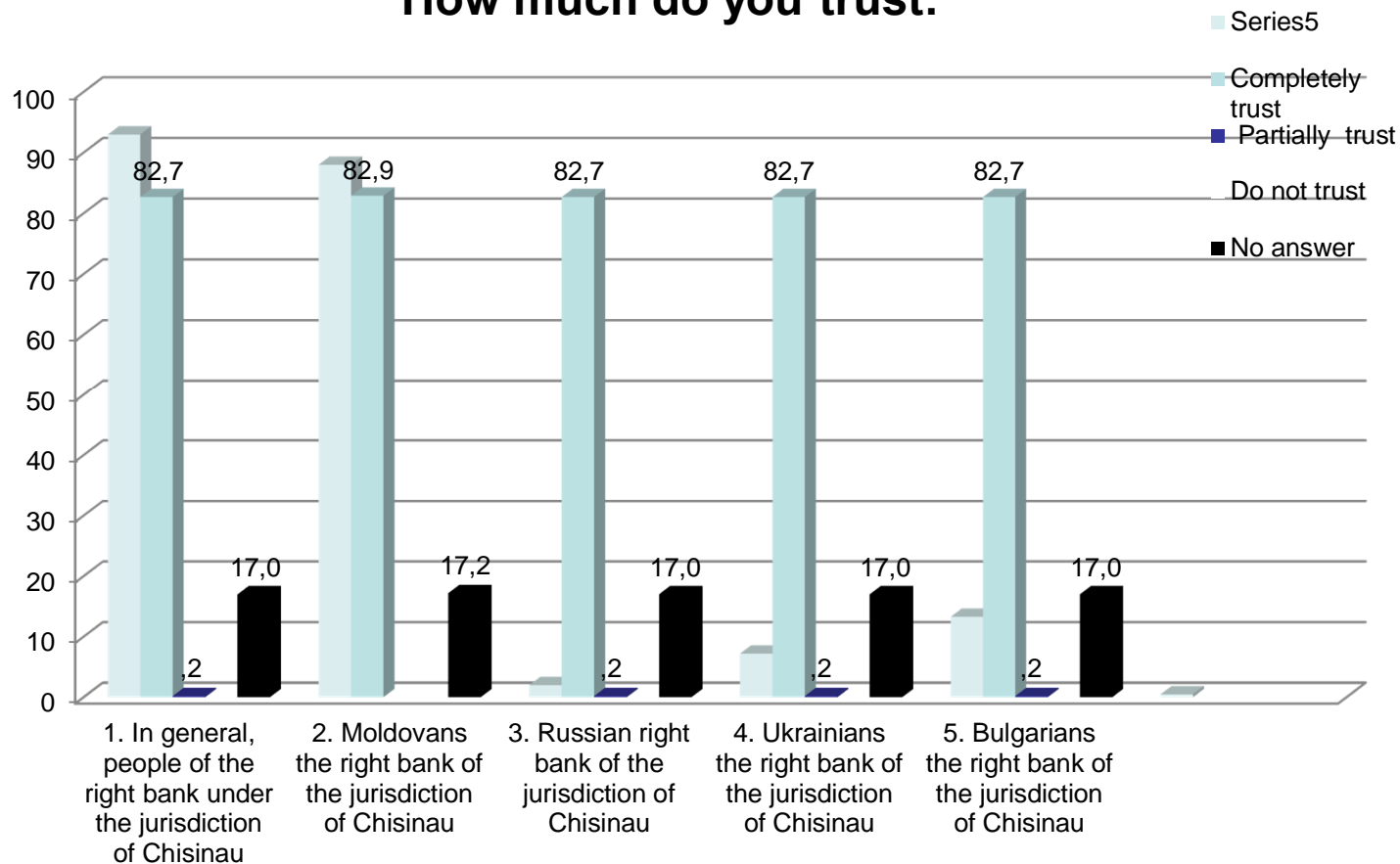

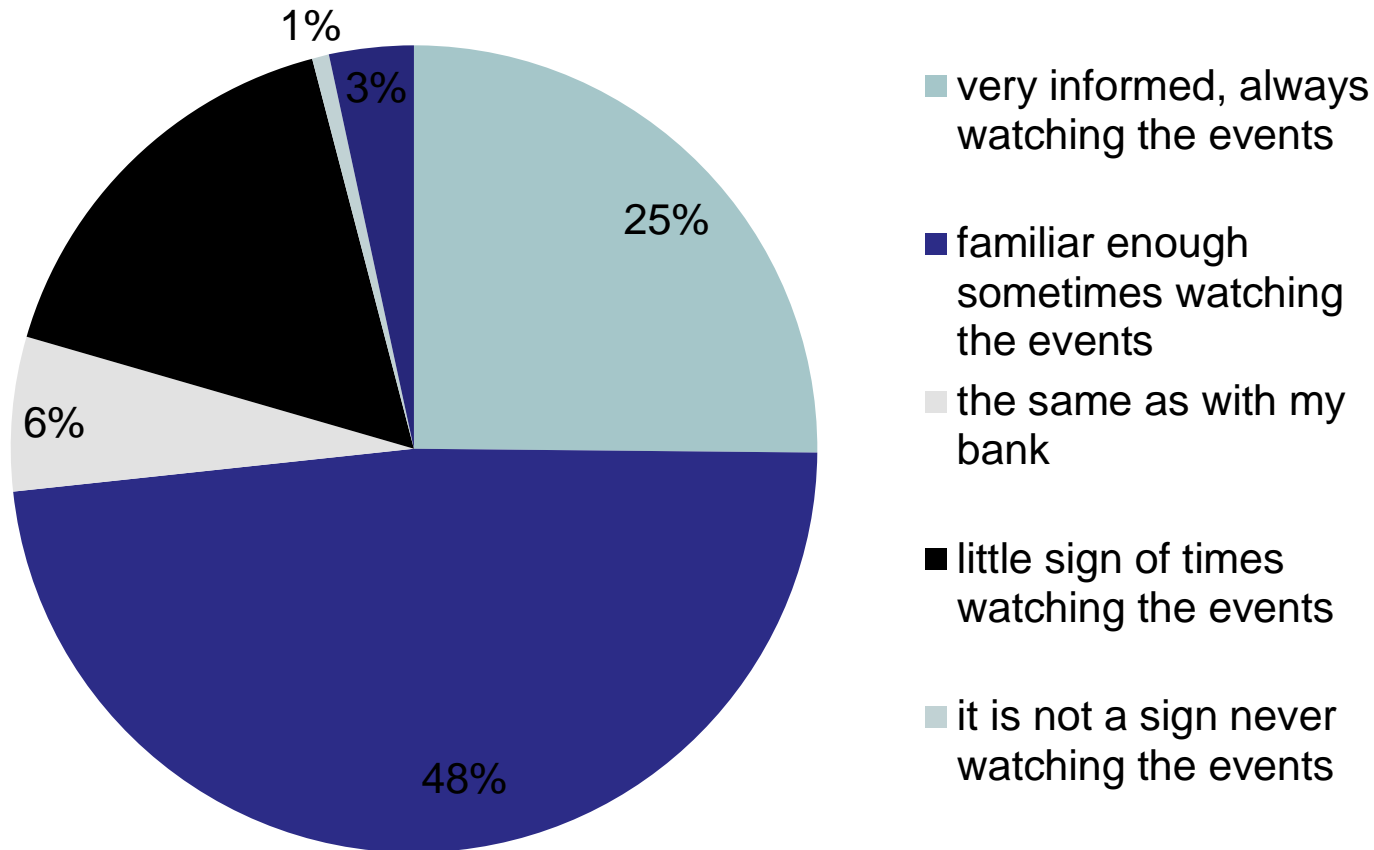

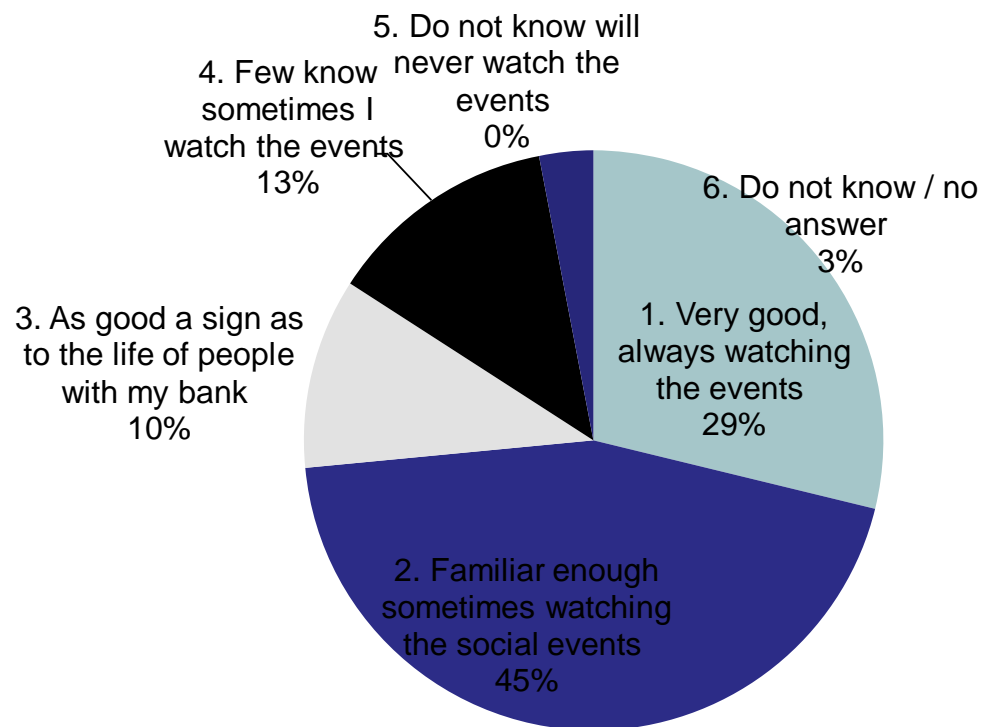

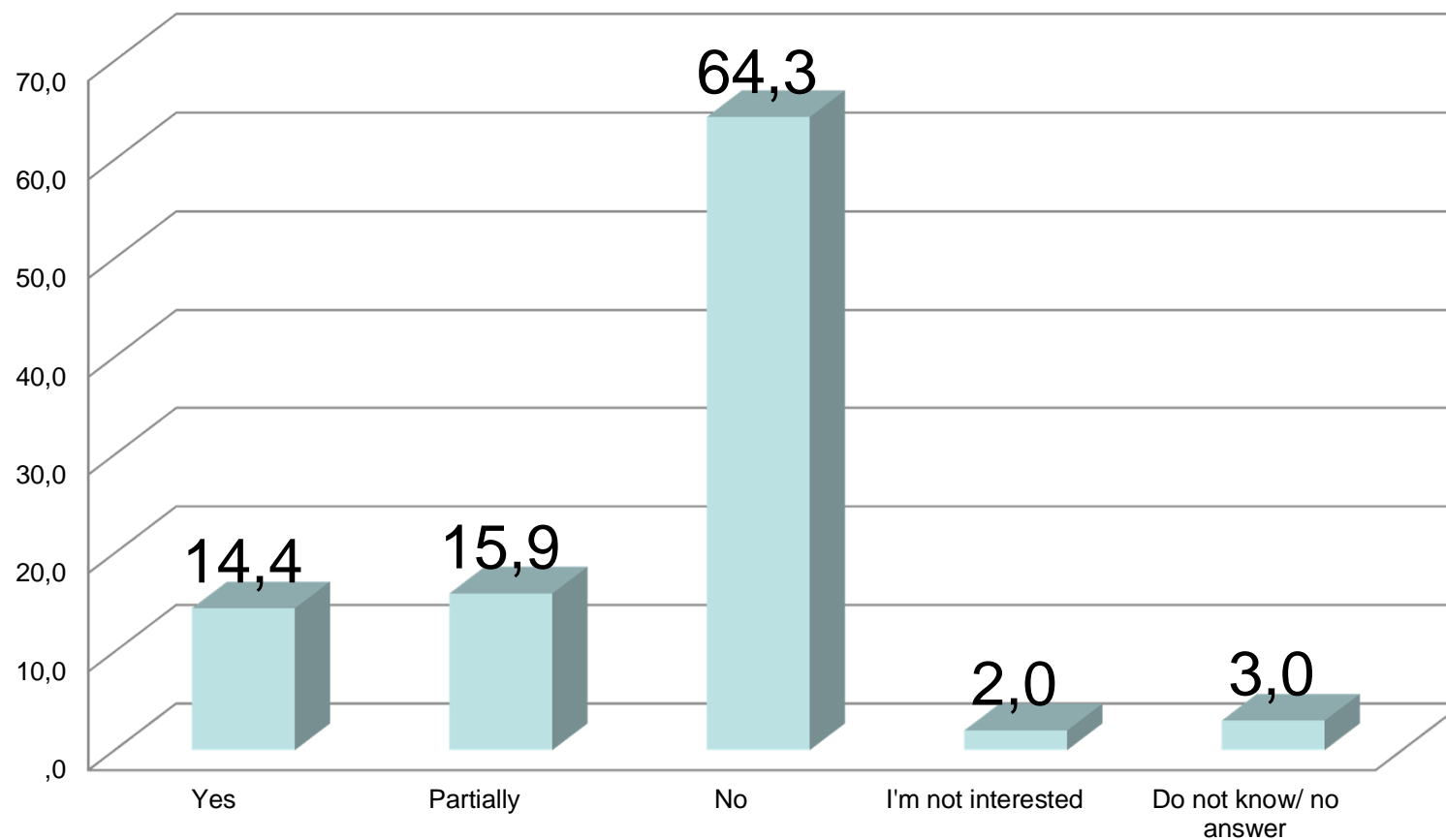

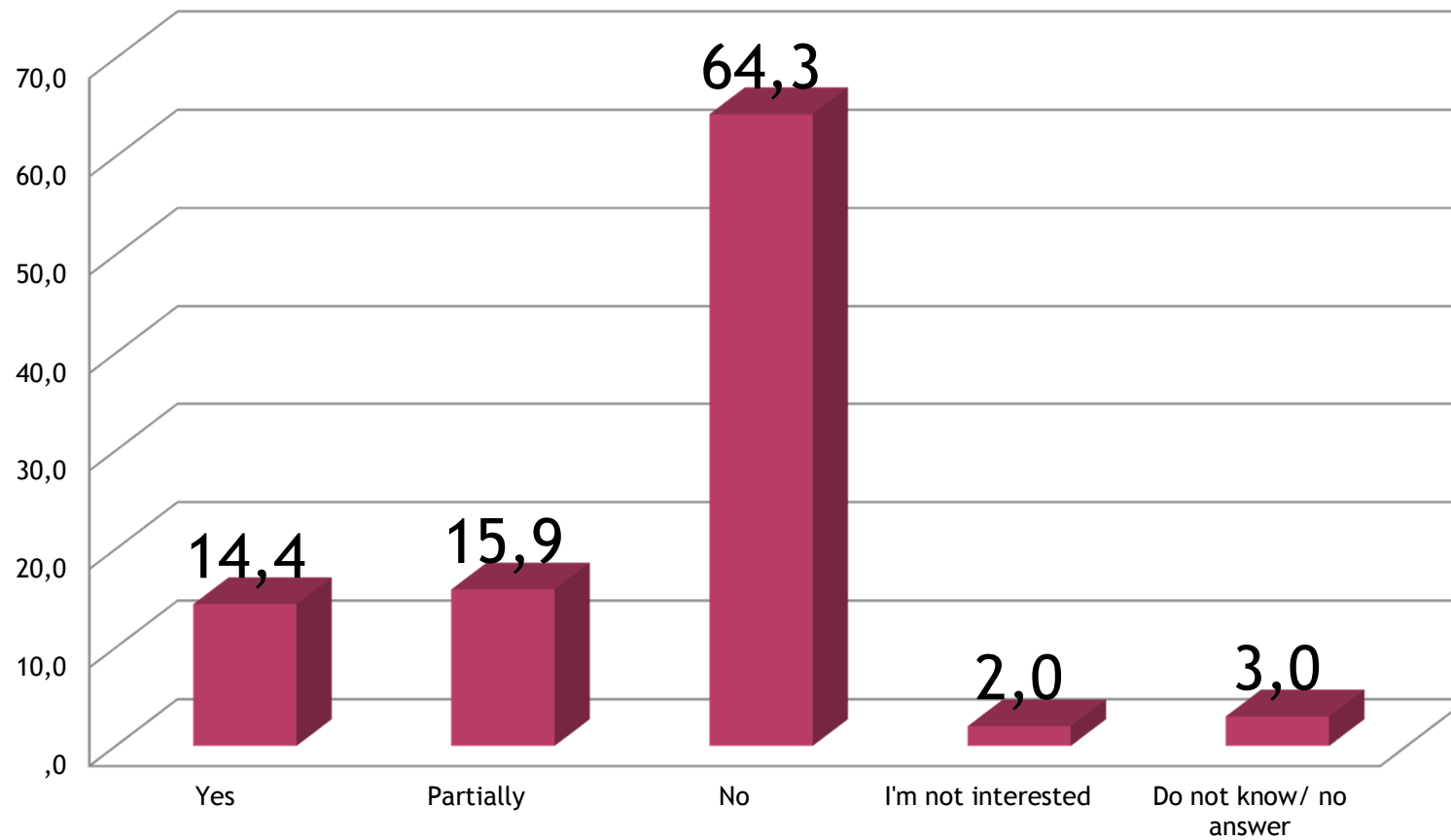

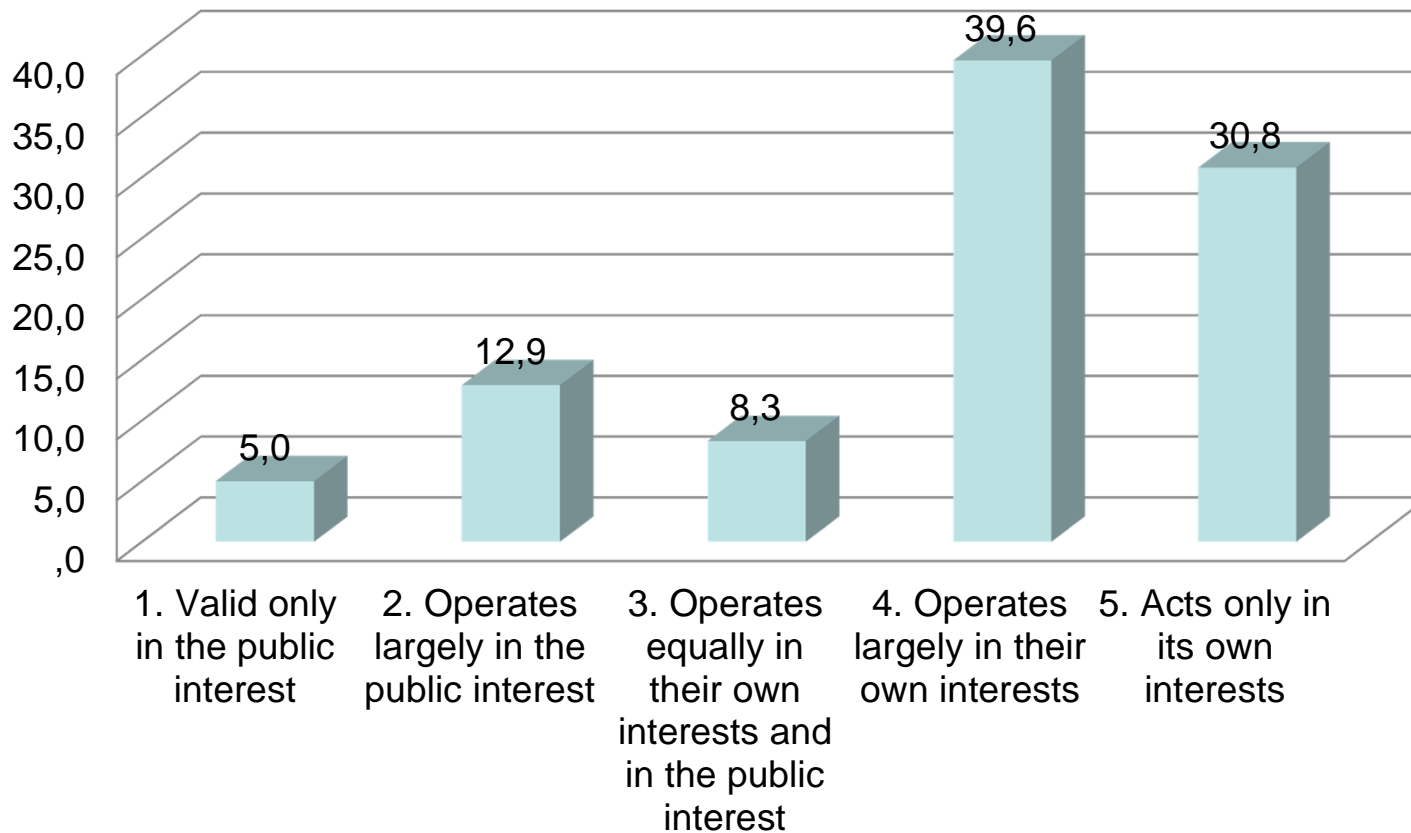

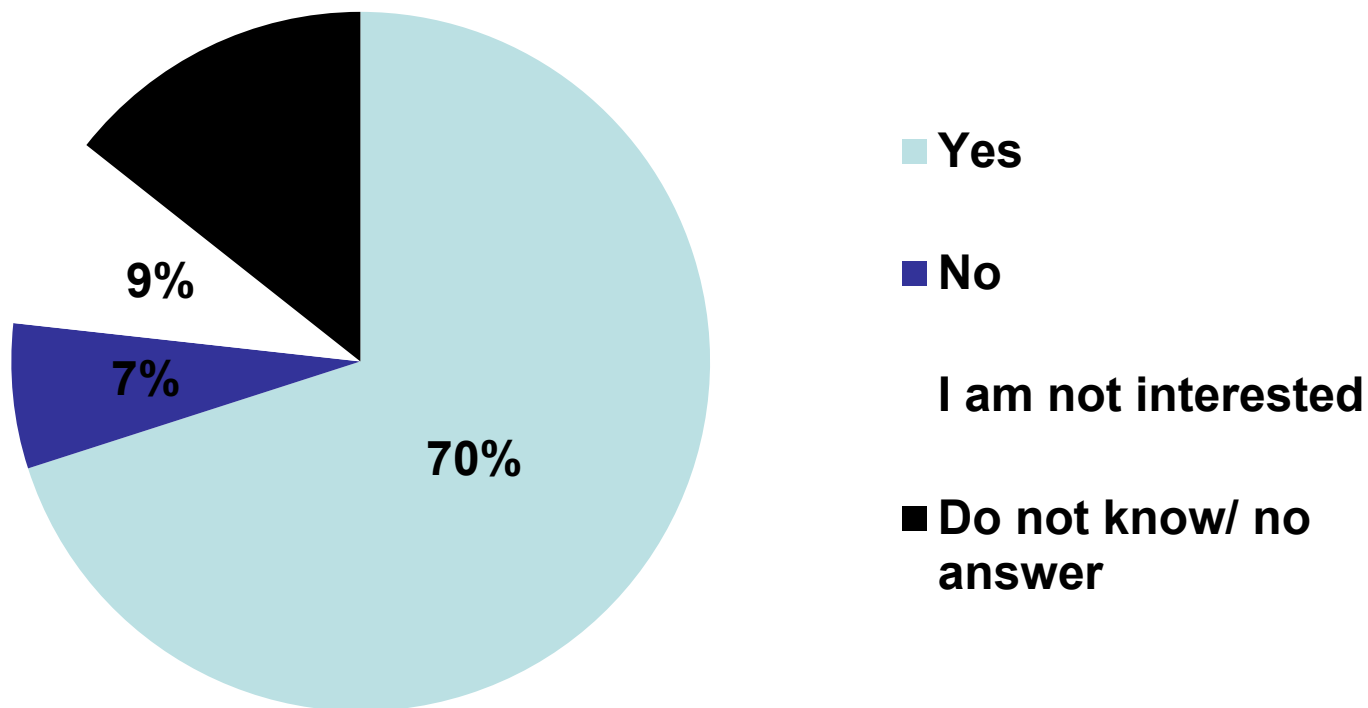
